IEOR, IIT Bombay, will be conducting **spot admissions** for its MTech program to fill up vacancies in its TA seats. **Spot admission date: Tuesday, 29th July 2025**

Eligibility Criteria for Spot Admissions TA Category

Candidates appearing for Spot admissions for MTech IEOR must satisfy all the eligibility criteria as given below:

1. Candidates should have already applied for M.Tech. IEOR Programme at IIT Bombay for the academic year 2025-26.
2. Candidates should NOT have “accepted” his/her offer in COAP.
3. Applicants who have accepted admissions at IIT Bombay or applicants who have marked “Accept & Freeze” on the COAP portal to accept the offer made by other Institutes, are NOT eligible for “Spot Admission”.
4. Gate score to be above the cutoffs

Candidates seeking spot admission have to **report in person on Tuesday, 29th July 2025, at 11:30 am.** Venue: Conference room, 1st Floor, IEOR Building, IIT Bombay campus.

- Candidates should submit the required documents (GATE scorecard copy and signed undertaking to be filled in person) to the IEOR office by 12:30 PM, 29th July 2025.
- No accommodation or travel allowances are given for attending this spot admission.
- Change in dates/ admission-by-proxy is NOT permitted.

Spot admission process for the TA category

Candidates who submit their documents by 12:30 PM only will be considered. The seats offered in each category are subject to the vacancies available in that category (See Table 1 below). The spot admissions process for the TA category will be as follows:

- The considered applicants will be listed as per descending order of their GATE score. From the top of the list, a candidate is selected. If the category has seats available, and the corresponding GATE bucket (see Table 2 below) has remaining seats, the candidate is shortlisted. The list is operated until the total vacant seats are filled. This is done for each category.
- The seats offered in each category are subject to the vacancies available (as given in Tables 1 and 2 below).
- In case there are insufficient applicants in a GATE bucket, the same will be offered to any remaining applicants as per GATE score from other buckets.

The spot admission consolidated merit /offer list will be displayed the **same day by 2 pm at the IEOR office**. Selected candidates will be required to submit a declaration confirming their acceptance of the seat.

NOTE FOR CANDIDATES WHO GET SPOT ADMISSION OFFERS:

1. Selected candidates will receive an offer letter on their registered email address, they will have to pay the fees on the IITB admission portal via ONLINE net Banking.

2. After payment candidates need to communicate the transaction details (UTR number) to the IEOR Office for their confirmation of admission at IIT Bombay.

3. If you have opted for Hostel Accommodation then you are required to submit the Mess Advance of Rs. 27,000/- by ONLINE payment/Net Banking as per the link provided in the online admission portal . The candidate shall directly contact The Deputy Registrar,Hostel Co-ordinating Unit(HCU), Ground Floor, Main Building, IIT Bombay on 022-25768900/8901 or email at arhcu@iitb.ac.in incharge.hcu@iitb.ac.in /hcu.office@iitb.ac.in, for all hostel related queries. Please note that the Institute provides accommodation on campus strictly for the stipulated duration of Programme under which one is admitted. Hostel accommodation facility is extended to FA/ TA/ RA/ TAP/ RAP/ SW(Monash) category students of all PG programmes. However, please note that due to the extreme paucity of hostel rooms at IIT Bombay the initial two years of accommodation will be in double occupancy.

4. IIT Bombay reserves the right to withdraw the admission at any stage / time in case a candidate does not fulfil the requisite qualifications and/or percentage of marks in qualifying degree or supplies any false information.

5b. Candidates wishing to cancel/withdraw admission after paying the requisite fees MUST communicate the same by an email given in the application form to pgadm@iitb.ac.in stating subject “CANCELLATION OF M.Tech. ADMISSION 2025-26 (On the spot admission offer)” by specifying the department/ specialization and application ID. E-mail regarding cancellation/withdrawal of admission will be entertained, ONLY IF, the request is made through E-mail ID given in the Application form.

5c. To process the refund you need to visit the IIT Bombay ONLINE application portal for cancellation request and to enter your own/Self Bank Account No., IFSC Code, Bank and Branch information and upload a proof of this account information. *The refund will be send to the respective candidate's Bank account from receipt of such e-mail/ request, and following the due process of refund, after verifying the details, within 8/10 weeks.*
